William Brown of Delaware Engineering was present to discuss the water infrastructure grant that the Village has been awarded. Mr. Brown stated that the cost of installing the new meters was included in the grant. It was agreed that the Village should hire outside contractors for the installation and that Delaware Engineering will provide the specs. Mr. Brown also recommended that the Village take out a Bond Anticipation Note (BAN) from our local bank to fund the work until the grant monies become available.

Deputy DPW Superintendent Matt Loftus submitted a letter re: the fire hydrant issues at the 12/8/18 trailer fire.

Dennis Mencer of Perkins Road addressed the Board regarding several "visual" conditions within the Village. Mr. Mencer's concerns pertained to old tires on numerous properties, the "junk" cars that have been parked for years at the Kaplan's Elm Street property, and the trash behind Little Italy. Mr. Mencer stated that there were many "eye sores" within the Village and requested that they be addressed.
